### **COUNTY JUDGE**

\* These offices are on the ballot to fill a vacancy. The two candidates with the highest number of votes in the primary will be nominated to the general election unless one candidate receives a majority of votes in the primary election. If one candidate receives a majority of the votes cast in the primary election, that candidate alone is nominated to the general election. The candidate that receives the highest number of votes at the general election will be elected to the office.

However, if only one or two candidates file for these offices to fill a vacancy, then those candidates shall be the nominees for the office and be forwarded to the general election. ORS 249.091.
