Dear Ms. Ferry:

We have received your notice of Proposed Civil Penalty, dated May 16, 2007, notifying us of the failure to submit timely reporting of the Second Supplement to the Second Pre-Election for the November 7, 2006 General Election.

We respectfully request a waiver of the \$870.00 civil penalty because we made a good faith effort to comply with the regulation.

On November 3rd, we attempted to submit the Contribution and Expenditure Report for the Second Supplement to the Second Pre-Election for the November 7, 2006 General Election. Normally, we submit these reports to the Elections Division electronically, and we never experience any problems. However, for the Second Supplement Report, the Elections Division requires that we submit this report by facsimile only. We attempted to do this (see the enclosure).

However, the report was not received by the Secretary of State Elections Division's office because the telephone lines were jammed by all the other political action committees submitting their reports by facsimile on that day. And as soon as my staff identified the failure of the transmission, we contacted the Secretary of State's office and submitted the Report. We feel that our efforts to comply with the regulations were done in good faith.
